Consequently, the staffing level is continuing to grow to meet the needs of our clients. In 2023 we opened an assembly plant in Kidderminster for our Net Zero Pod packaged plant room. Green electricity is bought from Octopus as of February 2024, replacing the supply from British Gas. As a business we continuously pursue ways of offsetting our carbon emissions. Senior team members have already switched to Electric Vehicles and employees are encouraged to change to lower carbon emission vehicles when possible
